## Corrigendum-II

It is hereby announced for the general information of the candidates that the Commission had advertised **1633 posts of Post Graduate Teachers (PGTs) in the subject of Computer Science for Rest of Haryana Cadre vide Advt. No. 26/2023 and 78 posts for Mewat Cadre vide Advt. No. 36/2023 in Secondary Education Department, Haryana.**

CWP No. 13697 of 2020 titled as Kapil Kumar and Ors V/s State of Haryana and Others and other connected cases were pending in the Hon'ble High Court regarding the qualifications required for the posts of PGT Computer Science. The Hon'ble High Court vide order dated 15.05.2025 has admitted these cases and it has been directed that the candidates who fulfill the qualifications under the Rules of 2012 for PGT (Computer Science) and the candidates who are eligible and possess qualifications as laid down in terms of Advt. No. 26/2023 and 36/2023 can participate in the selection process.

In view of the above **the Commission has decided to re-open the portal for inviting online application forms from all candidates who fulfill the present qualifications under the Rules of 2012 for PGT (Computer Science) and also the candidates who possess the qualifications mentioned in the advertisement No. 26/2023 and 36/2023, but had not applied earlier in response to advertisement No. 26/2023 and 36/2023.**

1. All **candidates who are applying afresh** in response to this Corrigendum-II are directed to read **Corrigendum dated 21.04.2025** available on the Commission's website and they should upload the required documents/certificates as specified therein.
2. The **candidates who have already applied** in response to advertisement No. 26/2023 and 36/2023 or in response to Corrigendum dated 21.04.2025 need not apply again. However all such candidates should upload the required documents/certificates as already specified in Corrigendum dated 21.04.2025.
3. The **candidates who have already applied** in response to advertisement No. 26/2023 and 36/2023 or in response to Corrigendum dated 21.04.2025 but could not upload the

duly signed application form after taking out the printout, such candidate are directed to apply afresh through online mode, after cancelling their previous application form.

4. The **candidates who had erroneously filled wrong particulars** relating to their category, qualification etc. in their previous application form should also apply afresh through the online mode, only after cancelling their previous application form.
5. **In case any candidate feels or finds out that he has filled any wrong particulars in his/her application form, such candidate should submit fresh application form by mentioning correct particulars**, after cancelling their previous application form. **This is the last and final opportunity for correction/amendment in the online application form.**
6. **The other terms & conditions mentioned in the advertisement No. 26/2023 and 36/2023 dated 24.06.2023 and Corrigendum dated 21.04.2025 shall remain unchanged.**
